Learner Outcome: Registered nurses will be able to articulate increased knowledge related to behavior and psychiatric mental health nursing by verbalizing the concepts, skills, treatments, strategies, interventions, and evaluation of care across the life span. All nurses will verbalize increased knowledge by self report of increased scores on the post test.

ANCC is a recognized certification granting organization permitting nurses to obtain certification and therefore be recognized for their acquired competency. This course has been updated to present current clinical practice issues. Leadership, professional roles, issues and trends, research, pharmacotherapeutics, milieu and therapeutic treatment interventions, advocacy and care coordination will be addressed using the nursing process. Foundational theories in communication and nurse-patient relationships will also be reviewed.

This course will validate what you already know and/or will help you identify areas of study where you need to developing a plan of study to prepare for the certification exam.

Who should attend: Nurses who want to validate and increase their knowledge while preparing to sit for the psychiatric nurse certification exam.
